However, Ivor Searle Limited cannot guarantee that any individual DPF will be refurbished successfully. In addition, Ivor Searle Limited cannot guarantee that the performance of the DPF (or associated vehicle) will pass any particular emissions tests after cleaning or the amount of time that the filter will remain clean or the lifetime of the filter. If a DPF becomes clogged (e.g. vehicle diagnostic warning light is illuminated) within 12 months as a result of inadequate cleaning by Ivor Searle Limited, then Ivor Searle Limited will arrange for and carry out a further clean on this part free of charge but only applicable to the vehicle to which it was fitted. This will include collection and delivery of the DPF but not removal and refitting of the DPF. As a test "pass" certificate will be issued with all successfully cleaned DPF's no warranty claim for labour time refitting or removing the unit will be entertained. **Ivor Searle standard terms and conditions of supply will apply, a copy of which is available free of charge upon request.**
